Perceived Influence of the Internet of Things on Implementation and Management of Big Data in Office Environments in University of Nigeria, Nsukka

Abstract

The purpose of this study was to ascertain the extent of implementation of the internet of things (IoT) and how IoT was viewed to affect the administration of big data in office settings in University of Nigeria Nsukka (UNN). The investigation was conducted using a descriptive survey design. Fifty employees from the e-learning centre, main library, bursary, old library, management information system, and Zenith ICT Centre all in UNN made up the study's population. The main tool for gathering data for the study was a structured questionnaire. Experts validated the instrument, and the final version was created by incorporating their recommendations and modifications. The instrument was trial tested with the same type of respondents in Federal University of Technology, Owerri and Imo State University, all in Imo State and a reliability coefficient of 0.77 was ascertained. The data collected were analyzed using mean and standard deviation to determine the current state of implementation, factors to consider and perceived impact of IoT in big data management practices in UNN. The findings indicated a poor state of availability and utilization of IoT devices in the offices. It also revealed that the staff (respondents) have an appreciable knowledge of the important factors to consider and the positive influence of IoT in big data management in modern offices. It was therefore, recommended that management support is required to acquire modern IoT-integrated electronics, technology and regular performance improvement of personnel involved for mega changes in offices.

Introduction

Many facets of life, including the way we work and manage data in offices, have changed significantly as a result of the quick development of technology. The Internet is defined by Comer (2017) as "a global system of interconnected computer networks that use a protocol suite to link devices worldwide." According to Tannenbaum and Wetherall (2020), the Internet "is a worldwide system of interconnected computer networks that use the standard Internet Protocol Suite (TCP/IP) to serve billions of users worldwide." Today, the internet has become a global phenomenon that is difficult to define comprehensively. However, a number of definitions have been put forward. For instance, the Internet is defined by Kurose and Ross (2020) as a network of networks that enables the

interconnection of devices that span the globe.

According to this study, the Internet functions as a worldwide system that makes it easier to connect for a variety of purposes, including social networking, e-commerce, management, communication, information retrieval. These days, the Internet affects all facets of our lives, including communication, business operations, entertainment, social interactions, commerce, security, and higher education, among other things. Based participation by the researchers with foreign institutions it was found that numerous academic institutions worldwide, such as Cornell, Oxford, Wisconsin, and the University of Leeds, are increasing their investments in information technology (IT), particularly the internet. and actively

encouraging internet usage. The revolutionary idea of the Internet of Things (IoT) has its roots in the Internet, a global network that links computers and makes information sharing easier. The IoT increases the reach of the internet by allowing physical items to be easily connected and share data, and revolutionizing various aspects of our lives.

The IoT as opinionated by Cisco Systems (2016) is "a network of physical objects accessed through technology that allows objects to be sensed or controlled existing across infrastructure." Gubbi et al (2018) described the IoT as a wide range of devices, from everyday objects to industrial equipment, creating a networked ecosystem that enables intelligent and autonomous interactions. The IoT is a network of interconnected devices that collect and exchange data, which contributes to the generation and utilization of big data. In this study, the Internet of Things refers to the network of physical objects or objects embedded with sensors, software, and connectivity capabilities, facilitating the collection and exchange of data over the Internet. Data from these interconnected things is routinely gathered, examined, and used to take action, offering a plethora of intelligence for decision-making, management and planning. Big data, to Marr (2015), refers to "extremely large datasets that may be analyzed computationally to reveal patterns, trends, and associations, especially relating to human behaviour and interactions." Gartner (2020) operationalizes big data as high-variety information assets that demand cost-effective, innovative forms of information processing for enhanced insight and decision-making. In this study, big data refers to extremely large and complex datasets that can be easily managed, processed, or analyzed using advanced technology for management decision making.

Management is viewed by Drucker and Maciariello (2014) as the process of coordinating and overseeing the activities of individuals and groups within an organization to achieve predetermined goals effectively and efficiently. Management is the process of

planning, organising, leading, and controlling resources to achieve organisational goals effectively and efficiently (Griffin Moorhead 2019). With reference to this management is the process study, organising, coordinating, planning, controlling resources and activities to achieve specific goals the effective and efficient utilisation of data for decision-making and operational purposes, known as data management.

Data management is a set of practices that support the transformation of data into information and knowledge (Aiken, 2015). Data management is the development and execution of architectures, policies, practices, and procedures that properly manage the full data lifecycle needs of an establishment (DAMA International, 2017). In this study, data management refers to various activities such as data collection, storage, retrieval, integration, disposal, transformation. security, and analysis in a structured and efficient manner for an establishment. The goal of data management is to ensure that data is accurate, consistent, and accessible for decision-making and business operations in an office.

The office is viewed by Barnes and Wagner (2016) as an avenue or designated space for capturing, processing, storing, retrieving, and dispatching transactional information. Robertson and Cooper (2019) described the office as a dynamic space that supports individual and collaborative work, fosters creativity, and enhances employee well-being. The office serves as a central hub communication, collaboration, productivity within an institution. University of Nigeria, Nsukka has many offices occupied by office workers for management of data for efficiency. The integration of Internet of Thing (IoT) technologies has the full potential to transform big data management in office environment in the university into a dynamic, real-time, and data-rich ecosystem. The adoption, implementation and utilization of advanced technologies of internet of things for the exchange of big data management has not been effective in the University of Nigeria. This might be a result of the cost of acquiring, implementing and maintaining the Internet of Things' electronic and Internet technologies for connectivity, others. Following the experiences of the researchers. traditional system of data management in various offices characterized with loss of data, linkages, alteration which cause delay in decision making and effective dissemination of information. governance policies, and the adoption of data analytics techniques. The identified challenge lies in the absence of studies to ascertain the perceive outcome of a comprehensive framework on effectiveness the integration, utilization of IoT technologies into the big data management practices of offices at the University of Nigeria Nsukka. This study seeks to examine perceived influence of the internet of things on implementation and management of big data practices in office environments in university of Nigeria, Nsukka.

Literature Review

Studies on the adoption of IoTs in institutions and enterprises in developing nations (Susilowati et al, 2021; Darvazeh et al., 2022) revealed that due to the young nature of the invention, previous research has human mostly linked resources information technology rather than IoT. Lugman and Van Belle (2017) found that developing nations such as experience serious challenges in IoT adoption such as unreliable infrastructure, connectivity and maintenance costs. Wees et al. (2016) reported a general slow adoption of IoTs while Zhou et al. (2017) revealed that developing markets will become essential drivers of technological innovation in products and systems when IoT is fully adopted. Findings by Mothobi and Gillwald (2018) revealed that there is a lag in ICT adoption in many parts in Africa's social, economic and academic activities. Mothobi and Gillwald (2018) further compared some African countries with South Africa having the most internet users who account for only half of the population which improved on

their revenues. Other studies, including Ogbuabor (2020) on data management, and Upasana and Msibi (2021) on the benefit of implementing IoTs, were reviewed.

Regarding the best practices for integrating the Internet of Things into big data management, research by Akande and van Belle (2013) showed that the ICT environment is constantly evolving, and institutions may find it challenging to stay up to date due to security regulations, policies, and laws that must adapt to these changes. Brown (2017) found that implementation enables monitoring performance metrics, gathering user feedback, and implementing necessary updates or enhancements to optimize IoT operations. Smith (2018) found that it involves integrating IoT devices and systems with existing infrastructure and processes to ensure smooth operations, which will enhance mega change. Johnson (2019) found that implementing IoTs enhances accurate and reliable data for making informed decisions and deriving meaningful insights from big data. Studies by the following scholars: Zhang et al. (2015); Wang et al. (2016) as well as Li et al. (2017) found that IoTs adoption advanced analytics techniques for extracting valuable insights from IoT big data. Wees et al. (2024) found implementing IoTs with functioning security enabled access control mechanisms of big data management efficiency.

Furthermore, a study by Smith et al. (2018) on the perceived impact of IoT on big data management methods discovered that IoT has a beneficial impact on data analysis, created data, and decision-making procedures. The use of IoT technology has increased the efficacy and efficiency of data processing in offices, claim Smith et al. (2018). According to Ogbuabor's (2020) findings, IoT improved the well-managed storage and organization of gathered data, as well as the availability of specialized staff or teams in charge of managing big data management in an office setting. According to submissions and findings by Jones and White (2017), Smith and Johnson (2018), Lee et al. (2019), Williams et al. (2019), and

Davis (2021), IoTs make it easier to capture, process, and make decisions quickly. The researchers were directed by the studied literature on the conceptual framework and study discussion were informed by the examined literature.

Examining the perceived impact of big data management techniques and the deployment of the internet of things (IoTs) in office settings at the University of Nigeria, Nsukka, is the primary goal of this study. The study specifically sought to ascertain the assess the current condition of big data management in the offices; perceived impact of IoT on big data management at the University of Nigeria, Nsukka (UNN); and ascertain the perceived influence of IoT on big data management implementation.

Research Questions

The following research questions guided the ICT departments of Imo State University, study:

Federal University of Technology, Owerri,

- 1. What is the current state of adoption of IoTs for big data management in offices in University of Nigeria, Nsukka?
- 2. What are the important factors to consider in implementing IoT in big data management practices in the University of Nigeria, Nsukka?
- 3. What is perceived influence of IOTs on big data management practices in the University of Nigeria, Nsukka?

Methodology

The research design used in this study was a descriptive survey. The study was carried out in the University of Nigeria, Nsukka (UNN). The study's population was 50 participants through purposive sampling. IT administrators who worked in the designated office settings where the internet of things should have been implemented were randomly chosen. The Innovation Centre, Centre for Distance & E-learning, Nnamdi

Azikiwe Library, Management Information System (MIS), and Zenith ICT Centre were the office settings where the study was conducted at the University of Nigeria, Nsukka.

A structured questionnaire created by the researchers based on a survey of the literature served as the data gathering tool. The research question guided the construction of the questionnaire. Three experts from the University of Nigeria Nsukka's Department of Business Education, one from Computer and Robotic Education, and a staff from Tenace ICT, all conducted face validity checks on the instrument. Their suggestions were taken into consideration when creating the final version of the survey. Trial testing was used to determine the instrument's reliability. Twenty copies of the survey were distributed to the Federal University of Technology, Owerri, and Imo State. These universities were selected because they have traits in common with the UNN offices but are not part of the study.

With the assistance of two research assistants, the researchers distributed fifty (50) copies of the questionnaires to the respondents, who then retrieved them. The following Likert scale was applied to code the responses: SA = 4, A = 3, D = 2, SDA = 1. The mean and standard deviation descriptive statistics were used to assess the data gathered from the respondents. A mean benchmark of 2.50 was used as the decision criterion for acceptance. As such items with mean ratings of 2.50 or higher were accepted, while items with mean ratings below 2.50 were not accepted.

Results

Research Question 1: What is the current state of adoption of IoTs for big data management in offices in University of Nigeria, Nsukka?

The responses on important factors to consider in implementing IoT in big data management underscore the significance of seamless integration, data protection, data accuracy, interdepartmental cooperation, and continuous improvement. The implementation of the Internet of Things (IoT) in big data management at the University of Nigeria, Nsukka requires careful consideration of best practices. These practices are crucial for ensuring seamless integration, data protection, data accuracy, interdepartmental cooperation, continuous improvement. Thus. respondents are unanimous on the importance of office. This indicates that the respondents have an appreciable knowledge of the demands and importance of IoT for big data management in modern offices, but lack the facilities to effectively implement IoT as indicated by the results from research question one. This finding on important factors to consider is in agreement seamless integration is essential for successful implementation and will enhance management decision making. This involves integrating IoT devices and systems with existing infrastructure and processes to ensure smooth operations. A study by Althoey et al. (2024) claims that implementing IoTs with functioning security enabled access control as one of the emerging technologies to facilitate mechanisms of big data management efficiency in offices. The findings further agreed with Johnson (2019) where accurate and reliable data is crucial for making informed decisions and deriving meaningful insights from big data. Johnson suggests that universities should establish mechanisms to ensure data accuracy, such as regular data validation and verification findings: IoT technologies have the potential to processes. Universities should continuously evaluate their IoT systems and processes to identify areas for improvement. In line with the departmental study, Brown (2017) concurred that the components implementation of IoT will involve monitoring implementation; and the current state of big data performance metrics, gathering user feedback, management at the University of Nigeria implementing necessary updates enhancements to optimize IoT operations.

The findings of the present study offer important insights into how IoT integration influences big data management in modern offices. The study found that IoT integration improves data collection and utilization in the office, that IoT-generated data has greatly increased the efficiency and effectiveness of data analysis, that IoT-generated data is more accurate and informative for decision-making than traditional data sources, that the office is successfully utilizing IoT technologies to improve big data management practices, and that, among other things, IoT-generated data is more accurate and informative for decisionmaking than traditional data sources. This further confirms the assertions of this study that these factors in the implementation of IoT in the respondents are well informed about the influence of IoT in modern office practices in big data management. The study's findings are consistent with a study by Zhang et al. (2015) that examined the perceived significance of data security and privacy in IoT big data management practices were found. The study further agreed with Ogbuabor (2020) where the perceived with that of Smith (2018) who concurred that importance of IoTs on storage and organization of collected data with the presence of dedicated personnel or teams responsible for overseeing big data management within the office were studied.

Conclusion

Internet of Things has been identified the management of office information in various institutions. This study ascertained the perceived influence of the Internet of Things on the implementation and management of big data practices in the office environment at the University of Nigeria, Nsukka. The following conclusions were reached in light of the improve data management practices; device compatibility, data security, and crosscollaboration are essential of best practices IoT for or requires significant improvements.

> The following recommendations made in light of the study's findings:

- i. To increase the accessibility and effectiveness of big data management, the university should upgrade its data management system with IoTs through its ICT unit
- ii. Top ICT personnel should start initiatives to educate and teach employees on data security and IoT technology.
- iii. To protect IoT-generated data, the University of Nigeria's ICT section should create and execute data privacy policies and security procedures.
